Misconduct Types

- 1.3 - Cautioned in three separate games with the same team
 - 1.5 - Cautioned five separate games with the same team
 - 1.6 - Cautioned in six separate games and any subsequent caution with the same team.
 - 1.13 - Dismissed for "receiving second caution in same game" for which neither of the cautions was directed at the game officials (s).
 - 1.14 - Dismissed for "receiving second caution in same game for which at least one of the cautions was directed at the game official(s).
 - 1.15 - Dismissed or reported by game official for "using offensive, insulting or abusive language and/or gestures" directed at anyone other than the game official(s).
 - 1.16 - Dismissed or reported by game official for "using offensive, insulting or abusive and/or gestures" directed at a game official".
 - 1.16A - Dismissed or reported for "using offensive, insulting or abusive language and/or gestures" directed at a game official(s) after having been previously dismissed or reported for using offensive, insulting or abusive language and or gestures" directed at a game official.
 - 1.17 - Dismissed for "denying the opposing team a goal or a obvious goal-scoring opportunity by deliberately handling the ball".
 - 1.18 - Dismissed for "denying an opponent a goal or an obvious goal-scoring opportunity, punishable by a free kick or a penalty kick".
 - 1.19 - Dismissed for "serious foul play"
 - 1.19A - Dismissed for "Serious Foul Play" where in the opinion of the Discipline Hearing Panel there was an obvious " attempt to injure" or " a complete disregard for the safety of an opponent".
 - 1.2 - Dismissed or reported for "spitting at an opponent or any other person"
 - 1.21 - Dismissed or reported for "violent conduct"
 - 1.21A - Dismissed or reported for "violent conduct" where in the opinion of the Discipline Hearing Panel there was an obvious "attempt to seriously injure an opponent", a registrant or non registrant.
 - 1.22 - Received and found guilty of a third dismissal in a season within that league or competition.
 - 1.23 - Senior player played as an ineligible player.
 - 1.25 - Reported for re-entered the field of play after having been dismissed from the game by the game official.

- FH - Failed to attend a hearing – suspended from all soccer activity
 - HR - D.B.H. required to attend next hearing – may continue to play until hearing
 - OF - Failed to pay DBR fine or DBH fine by the time required – suspended from all soccer activity
 - PS - Suspension carried over from previous season

 - TC - Received second caution in a tournament in last game played.
